# **Clerk of Courts:**

With recommendation from Kelly Lawver, Clerk of Court, Mr. Qually moved, seconded by Mr. Martin, to approve the following:

- The Board of Commissioners appoint Chairman Randy L. Phiel to execute on behalf of the Board the Agreement for Records Management and Imaging System with Kofile Technologies, Inc. of Dallas, Texas for the installation of Kofile's County Fusion recordation and document management system that scans, indexes, stores and retrieves Official Public Records (OPR), Vital Records, Case Management Services, and support for eFiling of documents, including software support. The term of the Agreement is five (5) years, and the cost is as follows: \$60,000.00 from the Orphan's Court Automation Fund and \$11,000.00 from the County's General Fund + \$15,000.00 due on the 1st anniversary of the Go Live date and each year for the remaining four (4) years of the contract, which constitutes an additional \$60,000.00 over the life of the contract for annual maintenance and support. There is a onetime purchase of a Microsoft SQL database license totaling \$5,549.44 to be paid out of the Orphan's Court Automation Fund.
- The County execute a Business Associate Agreement with Kofile Technologies, Inc. to ensure the safeguarding and proper security of private and confidential PHI and HIPAA health information.

This agreement will expire on September 30, 2021 and is conditioned on a non-federal match of 50% of eligible project costs.

# **Commissioners:**

 Mr. Qually moved, seconded by Mr. Martin, to approve and sign a Temporary Construction Easement Agreement between the County of Adams and Mason Dixon Country Club, Inc. for a certain tract of real estate located in Freedom Township, Adams County, Pennsylvania, known as Adam County Tax Parcel Number 13E18-0023-000, recorded in the Office of the Recorder of Deeds for Adams County, in Deed Book 4693, Page 0216. This temporary construction easement in consideration of One (\$1.00) Dollar paid by the County of Adams to Mason Dixon Country Club, Inc. is needed for the repair and rehabilitation of Adams County Bridge No. 5 (T-329) known as Shorb Mill Road Bridge.

Mr. Martin moved, seconded by Mr. Qually, to adopt Resolution No 6 of 2019 and execute the Certificate of Approval relative to the Cumberland County Municipal Authority SpiritTrust Lutheran Project, wherein the "Authority" has proposed to issue tax-exempt variable rate demand revenue bonds in the maximum aggregate principal amount of Seventy Million Dollars (\$70,000,000) (hereinafter, the "Bonds"), the proceeds of which shall be used to finance the costs and expenses of alterations, additions, renovation and improvements to the healthcare and retirement facilities known in Adams County as "The Village at Gettysburg," located at 1075 Old Harrisburg Road Gettysburg, Pennsylvania. The obligations to be issued shall not constitute a debt or obligation of the County, and the County hereby assumes no obligation whatsoever with respect to payment of same. Approval is given by the Board of Commissioners on behalf of the County of Adams as the political subdivision in which a portion of the properties being financed are located, and solely for the purposes of Section 147(f) of the Internal Revenue Code of 1986, as amended.

**RESOLUTION NO. 6 of 2019** 

WHEREAS, SpiriTrust Lutheran, a nonprofit corporation organized and existing under laws of the Commonwealth of Pennsylvania, owns and operates healthcare and retirement facilities known as SpiriTrust Lutheran LIFE Center Cumberland & Perry Counties, located at 1920 Good Hope Road, Enola, Pennsylvania; SpiriTrust Lutheran LIFE Center Franklin County, located at 840 Fifth Avenue, Chambersburg, Pennsylvania; SpiriTrust Lutheran Home Care & Hospice, located at 2700 Luther Drive, Chambersburg, Pennsylvania; The Village at Gettysburg, located at 1075 Old Harrisburg Road, Gettysburg, Pennsylvania, The Village at Kelly Drive, located at 750 Kelly Drive, York, Pennsylvania, The Village at Luther Ridge, located at 2998 Luther Drive, Chambersburg, Pennsylvania, The Village at Shrewsbury, located at 800 Bollinger Drive, Shrewsbury, Pennsylvania, The Village at Sprenkle Drive, located at 1802 Folkemer Circle, York, Pennsylvania, and The Village at UTZ Terrace, located at 2100 UTZ Terrace, Hanover, Pennsylvania (collectively, the "Facilities"); and

WHEREAS, Cumberland County Municipal Authority (the "Authority"), a municipality authority organized by the County of Cumberland, Pennsylvania under the Pennsylvania Municipality Authorities Act of 1945, as amended, now the Municipality Authorities Act, 53 Pa.C.S. Chapter 56 (the "Authorities Act"), proposes to act as a conduit issuer and to issue tax-exempt obligations in the aggregate principal amount not to exceed \$70,000,000 (the "Obligations") to: (a) finance the costs and expenses of alterations, additions, renovations and improvements to the Facilities; (b) refinance various taxable and tax-exempt obligations previously issued for the benefit of the Facilities; and (c) pay costs and expenses of the financing (collectively, the "Project"); and

WHEREAS, Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), provides that tax-exempt obligations may not be issued for the benefit of persons other than state and local governments unless the issue is approved by the "applicable elected representative" of a governmental unit having jurisdiction over the geographic location of the site of the facility to be financed and by the "applicable elected representative" of the governmental unit which will issue the tax-exempt obligations or, if such governmental unit has no elected officials, then by an "applicable elected representative" of the next higher governmental unit (with an "applicable elected representative"), in each case following a public hearing of which reasonable public notice is given; and

WHEREAS, the Board of County Commissioners of this County is the "applicable elected representative" of a governmental unit having jurisdiction over the geographic location of a portion of the Facilities; and

WHEREAS, notice of a public hearing with respect to the Project and the proposed issuance of the Obligations by the Authority as tax-exempt obligations was published in the <u>Carlisle Sentinel</u>, of Carlisle, Pennsylvania, the <u>Public Opinion</u>, of Chambersburg, Pennsylvania, the <u>Gettysburg Times</u>, of Gettysburg, Pennsylvania, and the <u>York Daily Record</u>, of York, Pennsylvania, newspapers of general circulation in the areas to be served by the Project; and

WHEREAS, a public hearing with respect to the Project and the issuance of the Obligations was held on September 19, 2019, at the time and place set forth in such notice, and a summary of public comments received at such hearing with respect to the issuance of the Obligations or the Project has been delivered to this meeting and been considered by the Board of Commissioners of this County; and

WHEREAS, the Authority has asked this County to approve the use of tax-exempt financing for the Project.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THIS COUNTY AS FOLLOWS:

1. The advertisement and conduct of a public hearing on behalf of this County regarding the Project and the issuance of the Obligations as tax-exempt obligations, as required by Section 147(f) of the Code, is hereby authorized, approved and ratified.

2. The Board of County Commissioners of this County designates and authorizes its Chairman or Vice Chairman to execute and deliver on behalf of the Board of County Commissioners of this County a Certificate of Approval with respect to the Obligations, such Certificate of Approval to be substantially in the form attached hereto as **Exhibit A**.

The approval granted hereby shall not, in any way, pledge or obligate the 3 credit or taxing power of the County, nor shall the County be liable for the payment of the principal of, or interest on, any obligations issued by the Authority as contemplated herein.

4. Nothing in this Resolution is intended to be, nor shall it be construed as, an approval of the Obligations or of the Project by this County for any purposes other than the public approval requirement of Section 147(f) of the Code.

All prior actions of this County and of the Authority taken in conformity 5. with the intent and purposes of this Resolution are ratified, confirmed and approved.

All prior resolutions or parts of resolutions, insofar as such shall be 6. inconsistent herewith, shall be and the same expressly are repealed.
