Minutes:

Mr. Martin moved, seconded by Mr. Qually, to approve the Minutes of the May 9, 2018 Commissioners' Meeting as presented.

Proclamations:

Mr. Martin moved, seconded by Mr. Qually, to adopt and proclaim May 2018 as
"LYME DISEASE AWARENESS MONTH" in Adams County. This proclamation was
presented to Sharon Shaffer, Regional Leader for the Adams County Region for the
PA Lyme Resource Network. Ms. Shaffer noted there will be a lecture on the affects

Presentation:

At this time Chairman Phiel recognized Steve Lyle, Executive Director of the Emergency Health Services Federation (EHSF), who presented ACDES Telecommunicator Samuel Biesecker with a commendation for his role in the successful resuscitation of a Cardiac Arrest patient in Adams County.

Public Comment:

- Will Tallman, 193rd State Representative Rep. Tallman was present today to express his opposition to the fair districts resolution. He stated there is no such thing as an independent commission and the Commissioners should not get involved. He asked the Board of Commissioners not to consider this resolution.
- Betsy Hower, Republican Committee Ms. Hower feels the congressional districts should be fair to all. She believes in the constitution as set forth by our forefathers and we should leave the decision to the legislators and that the Board of Commissioners should not consider this resolution.
- Graham Weaver, Gettysburg resident Mr. Weaver echos the same concerns as Ms. Hower. Leave the districts as they are so we do not lose our local representation. Independent commissions are unconstitutional.
- Steve Niebler, Fair Districts Adams County Fair districts is all about good government and fairness to all. Mr. Niebler provided an overview of facts and

information as to why an independent commission is important. We encourage you to support the resolution.

- Ed Chenney, Gettysburg Ward 2 Fair districting is a legislative issue and would require an amendment to the constitution.
- Chad Collie, Orrtanna, PA Thanked the Commissioners who work together to get things done. The end goal is to have fair voting for all. Fair districting, maybe we should let the registered independents vote in the primary.
