**Treasurer's Report:** Treasurer, Smith commented that there has been no activity, the balance remains at 7,946.68. The 2021 budget has been prepared.

Speaker: Laura Goss, Adams County Library: Ms. Goss is the Executive Director of the Adams County Library System. They are a non-profit organization and get approximately 50% of funding from the County. They are currently in the process of merging with the private East Berlin Library. They provide many programs, such as, Early Literacy, Story Times, 1000 Books Before Kindergarten, My First Card Program, Book Clubs, Stem Programs, Summer Learning and Fun Fest. These programs are geared toward children and adults. Books are quarantined for 6 days before being put back on the shelf. No meeting rooms are available at this time. Library cards are available to anyone at any age, they expire after 3 years but can be renewed over the phone.

## **New Business:**

- Nominating Committee: On behalf of the committee, Ferd Prehn, announced that the current officers are willing to stay on for another year.
- 2021 Budget: The Executive Board discussed how to move forward with next year based on this year's "issues". The Board determined that there will be no dues for any member in good standing as of October 2020. Non members wishing to join would still need to pay the membership fee.
