CHARGES FILED IN CHILD PORNOGRAPHY CASE

Today, the Adams County District Attorney's Office announced that charges have been filed against Kamran Saleem, 29, of Ellicott City, Maryland, for Possession and Dissemination of Child Pornography. *Please see attached Criminal Complaint and Affidavit of Probable Cause.*

Saleem was arrested after a tip was received by the National Center for Missing and Exploited Children, which indicated that Child Pornographic material was being shared via Facebook. A search warrant was served, and Saleem was taken into custody on the charges. The Adams County Detectives were assisted in the service of the search warrant by the Gettysburg Borough Police Department.

Saleem was arraigned by MDJ Matthew Harvey and committed in lieu of \$100,000 bail. A preliminary hearing is scheduled for 1 July 2020.

In this case, as with all criminal cases, the defendant is presumed innocent until proven guilty.

AFFIDAVIT of PROBABLE CAUSE

I, Detective Eric B. Beyer of the Adams County District Attorney's Office, believe the following information to be sufficient probable cause to charge Kamran Saleem with the offenses listed on the attached and incorporated Criminal Complaint.

On 16 March 2020, I was assigned to investigate CybertipLine Report 63516377, (CT Report) submitted by the National Center for Missing and Exploited Children. (NCMEC) This CT Report 52802872 was submitted by Facebook Inc., which reported that a video file was shared via Facebook Messenger. This video was shared on 25 January 2020 at 14:08:10 UTC. As part of this report, NCMEC included the suspect file. This video depicted a male child approximately 10 to 12 years old, nude, on his hands and knees on a bed. The child is manually stimulated by an adult male, who then engages in sexual intercourse with the child, or simulates this act. During this act, the child is gagged with tape across his mouth.

Facebook, Inc. included data related to the user account that was reported to have shared this image via Facebook Messenger. This data included a user name of Kamran Saleem, email address of kamransaleem.kami@yahoo.com and a cellular telephone number of 443-325-8353. Both the email address and telephone number were verified by the user. Verification occurs when the user responds to messages sent to them by Facebook, and enters information given to them, such as verification codes, in response to emails or text messages that Facebook sends to them.

Included in this report was the IP address used to upload this image, 2603:3007:900:4700:5087:a41d:7040:4532. As part of this investigation, the aforementioned IP address was searched for in ARIN, which resulted in the information that this IP address was assigned to Comcast Internet Services.

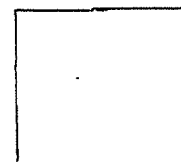

Based upon this, on 17 March 2020, an Administrative Subpoena was forwarded to the Comcast Legal Response Center for the subscriber information for IP address 2603:3007:900:4700:5087:a41d:7040:4532. On 17 March 2020, Comcast Legal Response provided records completed during the normal course of business that indicated that the subscriber information for IP address 2603:3007:900:4700:5087:a41d:7040:4532 was

On 18 March 2020, I contacted Officer Bryan Holden, Gettysburg Borough Police Department, and provided him with a photograph of Kamran Saleem. Officer Holden stated that he has personally observed Kamran Saleem working at Gettysburg American Fuel, 243 Steinwehr Ave, Gettysburg PA, 17325.

On 26 March 2020, I served a search warrant to Facebook Inc., for the content of the reported Facebook page. On 30 April 2020, I received the content of the aforementioned Facebook page, which included a chat conversation between the Facebook profile identified as Kamran Saleem's and a Facebook profile identified as Sher Nabi Khan (100008613781507). During this chat conversation, on 25 January 2020 between 1401 hours UTC and 1409 hours UTC, the Kamran Saleem profile sent two separate videos of child pornography. Both videos depict a male child, approximately 10 to 12 years old, nude, on his hands and knees on a bed. The child is manually stimulated by an adult male, who then engages in sexual intercourse with the child, or simulates this act. During this act, the child is handcuffed and gagged with tape across his mouth.

On 24 June 2020, I made contact with Kamran Saleem at 243 Steinwehr Ave, Gettysburg, PA 17325. Saleem was served with a search warrant for his phone and an interview was conducted with him. After being advised of his Miranda Warnings, Saleem admitted to possessing and disseminating the reported videos, which he admitted were "child exploitive" materials. He stated that he sent these videos to a friend of his that lives in Italy.


