New Business:

- PCCD Grant Opportunity Detection & Mitigation of COVID-19 in
 - Confinement Facilities: A new grant opportunity related to the implementation of new COVID-19 detection and mitigation practices, as well as the enhancement of current practices, was announced by PCCD on August 8, 2023. This is a noncompetitive grant and based upon the formula, Adams County is eligible for up to \$103,535.00. The project start date can also be retroactive to August 1, 2022, allowing for reimbursement for COVID-19 related expenses that have already been incurred. With Solicitor Mudd's approval due to the compressed application and submission timeline, I did put together a grant application and have provided it to her for legal review. The application is for \$103,516.00 that will be used to reimburse \$20,350.00 for the cost of COVID-19 testing at the ACACC between August 1, 2022 and July 30, 2023, as well as \$83,166.00 of purchases in year two of the project period. The items suggested for purchase with these grant funds include:
 - UV technology and upgrades to improve facility-wide disinfection/sanitation and air quality at the ACACC
 - Ongoing COVID-19 testing prior to placement in general population
 - To purchase personal protective equipment
 - To provide the Adams County Sheriff's Department with three (3) electrostatic disinfectant machines and solution for use in the holding cells at the Courthouse, HSB, and transport vehicles

I am asking for the Prison Board's support of this grant application to support the continuation, enhancement, and implementation of strategies to mitigate COVID-19 at the facility. Provided that the application receives Prison Board support and passes legal review, it is anticipated to be added to the agenda for the September 13, 2023 Commissioner's Meeting. The application must be submitted to PCCD by September 19, 2023.
