## Strawberry Hill Preservation

Strawberry Hill Nature Preserve, just outside Fairfield, is an extremely valuable environmental classroom for Adams County. Last week Strawberry Hill officially transferred 560 acres of land to the Pennsylvania Department of Conservation and Natural Resources. The transfer has been in the works for many years. While assuring this green space is protected for perpetuity, it is not expected to have any impact on visitors' experience to the area for hiking and other programs.

Strawberry Hill will still operate as an educational facility with classrooms, pavilion, pond and streams. The nature preserve is a popular location for student field trips. The transfer now presents new adjoining access for hikers and outdoor enthusiasts to Michaux State Forest, an 85,000-acre tract of land in Adams, Cumberland and Franklin counties. Strawberry Hill will continue to host events such as Summer Adventure Camp, PA Master Naturalist, the Twisted Turkey Trail Tussle race in November and the Mount Hope Maple Madness every winter. ## Adams County To Enhance Email Security

The Information Technology Department is in the process of testing out a new security feature specific to County users receiving emails from outside the County email system. It includes a simple yellow banner that will begin to show up every time you receive an email that is not from a @adamscounty.us email address. This simple banner (shown below) is used as a reminder that the email you received is from someone outside of the County. The banner will show up whether the email received is safe or malicious- It is NOT a virus checker. A follow up email will be sent out on Monday, 9/17 with more information. The test pilot will begin on Tuesday, 9/18

**CAUTION:** This email originated from outside of the organization. Do not click links or open attachments unless you recognize the sender and know the content is safe.


