Public Comment:

John Horner, Cumberland Township Resident – Discussed a situation and his concern regarding his farm, which was put in to the 2008 Ag Preservation Program. He set aside a 5 acre lot with the intent to sell and if he does sell, it will trigger the Clean & Green roll back taxes. He does not feel this is fair. Daryl Crum, Director of Tax Services, explained that the tax law allows for a 2 acre lot/year to be sold without the roll back taxes being applied.

Children and Youth Services:

The term of the Agreement is for one (1) year, renewable for subsequent one (1) year terms, at no cost to the County.
