MEETING MINUTES: A MOTION WAS MADE BY FRIDENVALDS (HUNTINGTON TOWNSHIP) AND SECONDED BY SWALES TO ADOPT THE JULY 25, 2013 MINUTES. MOTION CARRIED UNANIMOUSLY.

TREASURERS REPORT: Emma Seibert (TYRONE TOWNSHIP) presented the Treasurer's report which showed the balance of \$7,226.99 and there was no activity for this month.

- **NEW BUSINESS:** President Gordon announced that this portion of the meeting would be dedicated to the updated information from the Emergency Services Committee and their work on the Fire Study. Gordon asked Sharon Hamm (STRABAN TOWNSHIP) and Dave Martin (FAIRFIELD FIRE & EMS COMPANY) to address this information. A report and discussion was given by Hamm and Martin for potential procedure for distribution and accountability of tax money collected and provided information packets to the members. These packets will be provided to the municipal offices and fire departments via email subsequent to this meeting. Hamm provided a list of the Ad Hoc committee that helped establish these procedures. The packet provided to everyone included a possible procedure to follow for accountability & distribution, a budget template for the fire departments, defined operational expenses, and sample Memo's of Understanding (MOU). The discussion clarified the importance of having a working relationship between the municipalities and their fire departments. Kevin Moul (UNITED HOOK & LADDER FIRE DEPARTMENT) explained the current environment for Worker's Compensation Insurance Rates facing municipalities and fire companies due to the recent enactment of Act 46 of 2011, The Firefighter Cancer Presumption Law compensation. Hamm announced a 2nd Follow up evening meeting to discuss a potential procedure between the municipalities and fire departments for distribution and accountability for tax money collected to be held on Tuesday, September 10, 2013 at 7pm at EMS Facility on Greenamyre Lane. All are welcome.

President Gordon introduced Adam McClain from Adams County Conservation District. McClain provided a presentation on Adams County Conservation District's Model Well Ordinance.
