- 1. The meeting was called to order by President Scholle at 8:31 a.m.
- 2. Pledge of Allegiance
- 3. Roll Call:

- 4. Minutes: A motion was made by Mauser, seconded by Bower to approve the September minutes as presented. Motion carried.
- 5. Treasurer's Report: Balance in checking account is \$10,029.92. A motion was made by Mauser, seconded by Phiel to approve the report as presented. Motion carried.
- 6. Speaker: Superintendent Bigger gave a video presentation on Mental Health in the Schools, what they see in the schools and the realities of how it has strained the school systems' budgets and employees. He answered questions immediately following.
- 7. New Business: Copies of the by-laws had been emailed to members, for discussion at the November meeting.
- 8. Regular Business:
 - a. Adams County Commissioners:

Randy Phiel anticipated no tax increase for the county. The Election Office is up and running in the Emergency Services Building lobby. The First Responder tax credit was approved, up to \$250 credit if thresholds are met. Glass Recycling at the Adams County Emergency Services Building will officially begin with a ribbon cutting on November 4th, and continue every other Saturday from 9:00 a.m.-12:00 p.m. Jim Martin noted the Collaborating for Youth county program and the 4-H programs for mental wellness.

Marty Qually reminded those present that state funding for mental health had been cut by 10% 14 years ago, and not restored.

- b. Legislative Representatives:
 - Nancy (Cong. Joyce) advised that there is now a Speaker of the House in D.C. Chris Kimple (Rep. Moul) advised that Act 18 (Dog Bill) increases some licensing fees. Although the budget was passed in June, fiscal code bills have not yet been passed.
- c. ACOPD: Andrew Merkel noted that there is at least one seat is open on ACTPO.
- d. Township Association: The convention will be at SAVES on November 15th.
- e. Borough's Association: Ron Harris noted that the next meeting will be November 20th at 7:00 p.m. at the AC Emergency Services BLDG. By-laws will be updated and

- election of officers will take place. Mr. Harris will not seek another term as he has served as president for 17 years.
- f. PSP: Lt. Haines advised that sighting PSP marked cars at school campuses should not necessarily be a scarey sight as they regularly make contact with the districts.
- g. Destination Gettsyburg: Carl Whitehead reported that September occupancy was up, with October a bit slower due to several rainy weekends affecting festivals. They are still working on a solution to the bus parking issue.
