**TREASURERS REPORT:** Emma Seibert (TYRONE TOWNSHIP) presented the Treasurer's report which showed the balance of \$5,861.04 as of 10/6/13.

**NEW BUSINESS:** President Gordon introduced Joan Stremmel from the SPCA who presented their ongoing operations and the current Capital Campaign called "Raise the Woof" for an addition to the current structure. Joint Purchasing was reported on by Gus Fridenvalds (Huntington Twp). He reported that some changes were being made to the packet this year. The items bid on will be line painting and stone (types of stones do not have be described in the bid) since the contractor will allow the bidders to determine their type of stone at the time of purchase. Hamm (Straban Twp) explained the need to simplify the process. The committee plans to have the packets out in January.

- President Bob Gordon (HAMILTONBAN TWP) reported on the Legislative Committee. He announced the Senator Policy Committee Hearing being held in Adams County and hosted by Senator Alloway on October 25, 2013 from 10 a.m. to 12 p.m. The Senate membership includes the EMS Preparedness Committee and Veteran Affairs Committee. Commissioner Randy Phiel has scheduled the testimonies on Fire and Emergency Services and invited everyone to come to witness the process.
- Public Works Committee Chair, Emma Seibert (TYRONE TWP) reported on the Public Works breakfast which was held on October 2 and announced that an email survey on the breakfast will be sent out to the members. Also, Eloise Swales (YORK SPRINGS BOROUGH) resigned from the committee. Seibert asked for volunteers for this committee. The committee is considering some future presentations on local Pesticide Certification and Emergency Planning. - Adams County Commissioners - Randy Phiel explained that meetings are being held with the ALS Steering Committee. The Commissioners are meeting with Wellspan, COG and ACVESA. This is in the preliminary stage with more information to follow.

Further, Phiel announced the ground breaking for Gettysburg Station site on this date to ready it for development. He stated that the broadband development is critical for economic development in the county. The anniversary of the Gettysburg Address which is to be held on November 19 has invited President Obama to be the keynote speaker.

Jim Martin announced the November 5, 2013 election day from 7AM to 8PM. Handouts will be provided on voter identification. He reiterated the current transportation bill which is in the House of Representatives includes a Prevailing Wage amendment. He suggested we contact our state representatives on this issue since prevailing wage has a lot of effect on cost of fixing roads and bridges. He announced the Drug Take Back on October 26 at various locations around the county.

Marty Qually reported that the county has applied for a line of credit vs. using bonds. The reason is due to the lower interest rates available at this time. The county hopes to preserve its bond rating which directly affects municipalities that apply for loans and the interest rate they receive. He suggested municipalities consider the same.

- Judy Chamber, PENN STATE, announced that Newly Elected Officials training will be presented in Gettysburg by PSAB in January 2014.
