Comments received:

• Scott Klunk, Oxford Township resident – Mr. Klunk expressed some concern about approving the TIP, particularly with regard to the Eisenhower Extension Project (MPMP #58137). Specifically, he expressed concern regarding the pending litigation over the EIS and discrepancies in the JMT traffic study.

Response: Staff indicated that ACTPO and PennDOT were aware of the pending litigation on this project. Staff noted that since the purpose of the TIP is to allocate transportation funding, it was developed to account for Eisenhower Extension project proceeding through the remaining project phases (design, utilities, right-of-way, construction) as planned. However, it was also noted that ACTPO and PennDOT were aware that the TIP may need to be revised if there were impacts to the project schedule based on the outcome of the pending litigation.

May 13th to June 13th, 2024 – Public Comment Period

The following comments were received during the 30-day public comment period.

 Representative Dan Moul's Office inquired about the Mason Dixon Road over Rock Creek, MPMS #99832, bridge replacement project regarding some outreach regarding adding bicycle/pedestrian facilities to the project.

Response: Staff provided an update on the project. Staff also discussed the status of the project design the PennDOT District 8 staff and provided a further update on this project to both Rep. Moul's office and a party local to the bridge.

2) Representative Dan Moul's Office inquired about a maintenance schedule for Whitehall Road (SR 2002) beyond sealcoating within the next 1-2 years.

Response: Staff provided some background on past repaving projects programmed on the TIP and noted that ACTPO typically relies on PennDOT's engineers and staff to identify candidate repaving projects.

3) Marcia Wilson, Mount Pleasant Township Resident, provided a comment in support of the Eisenhower Drive Extension project.

Response: Staff acknowledged receipt of the comment, which is included in the full public comment period documentation.

4) Andrew Smith, Conewago Township Resident, provided a comment regarding the Eisenhower Drive Extension project. Specifically, Mr. Smith indicated concern that the intersections of PA 116 and roads leading to/from Eisenhower not be overlooked. An example of the PA 116/ Oxford Avenue/Elm Avenue intersection was included with the comment. Mr. Smith also asked to be placed on any notification lists for other transportation updates.

Response: Staff acknowledged receipt of the comment, which is included in the full public comment period documentation. Staff responded that there will always be a need to monitor intersections and road corridors to determine if they are operating safely. If there proves to be a need for additional improvements to address safety or other issues, then those will need to be addressed. Staff also added Mr. Smith to the distribution list maintained for ACTPO meeting.

5) JoAnn Leonard, Conewago Township Resident, provided a comment regarding the Eisenhower Drive Extension project. She also provided comment in response to the June 11th Gettysburg Time article regarding the TIP public meetings held on June 5th.

Response: Staff acknowledged receipt of the comment, which is included in the full public comment period documentation. Staff provided a detailed list of the outreach activities used to advertise and disseminate information on how to attend the June 5th meetings.

Chris,

There are two primary paths that maintenance of state roads can proceed.

The first path is through PennDOT Department Forces work. This work is done out of the PennDOT Adams County Maintenance Office. Attached is the 2024 construction schedule map we got from PennDOT. The green lines represent the Department Forces work for this construction season (i.e. sealcoat / tar and chip). In the past PennDOT would move randomly around the county each year. Now, they rotate around the county and focus in one specific area. In 2023 the focus was on the NW part of the County. This year the focus in on the SW corner. I would venture a guess that the focus in 2025 would be the SE corner, which would mean that Whitehall Road could be a sealcoat/tar and chip candidate.

The second path is through the TIP. ACTPO has traditionally relied on PennDOT to develop the list of maintenance candidates for the TIP for more in depth repair work. Given the funding challenges ACTPO has had for many years, most of the TIP level repaving work has been focused on the National Highway System (NHS) roads (US 15, US 30, PA 94) and arterial roads (PA 97, PA 116). For example, the draft 2025 TIP contains two repaving projects, US 15 (MD Line to PA 394) and PA 94 (from Gun Club Road to Mud Run).

Now, certainly if road conditions warrant or traffic patterns change on a minor arterial or major/minor collector road, then it could be advanced on the TIP. However, ACTPO would still rely on feedback from PennDOT's engineers to determine the best course of action.

For reference, Whitehall Road is a Major Collector (see attached map). I have also attached the matrix that ACTPO (and the York County MPO) use when evaluating the functional class of roads.

If there proves to be a need for additional improvements to address safety or other issues, then those will need to be addressed. If/when it moves forward, it may take some time for new traffic patterns to show once the Eisenhower Drive Extension is in place.

I do know that there have been multiple discussions about the 116/Oxford Avenue/Elm Avenue and 116/3rd Street intersections with both Borough and Township officials over the past 25+ years. Balancing improvements with the limited space available without impacting structures or business access points has always been one of the trickiest issues along the entire 116/Elm Avenue corridor in this area.

Mr. Merkel,

Thank you for the opportunity to provide public comment regarding the Eisenhower Drive Extension project noted in the TIP documentation.

I would like to express my concern that the impact on intersections of State Route 116 and roads leading to/from the Extension not be overlooked or under-considered. I suspect that the change in traffic patterns will impact both the roads between the Extension and 116 more than thought, and in particular, the intersections with 116 will be considerable.

As one example, the intersection of State Route 116/Third Street, McSherrystown's Main Street, West Elm, and North Oxford will likely see a significant increase of traffic to and from the Extension. Travelers on 116/Third Street heading (north)west on 116 and needing to turn left (as indicated in the attached image) to stay on 116/Main Street already face significant delays during heavy traffic periods. With the potential for increased traffic on Oxford Avenue from the Extension heading SE into Hanover, that left turn for those hoping to stay on 116 West may become unmanageable without a dedicated left turn signal.

As a side note, while I am on the email list specifically for the Extension, if there is a notification list for the TIPs or other transportation updates, I would like to be placed on it.

The June 5th meeting was not a meeting about only the Eisenhower Drive project. It was a meeting to discuss and receive comment on the draft <u>2025 Adams County Transportation Improvement</u> <u>Program (TIP)</u> as part of the required 30-day public comment period on the TIP. The TIP covers projects across all of Adams County, not just Eisenhower Drive.

The meeting was advertised in the Gettysburg Times, Hanover Evening Sun and the York Daily Record. The York Daily Record was added to this TIP update cycle at the request of a previous public comment we received on the 2023 TIP regarding this very issue. The paid advertisements were published at the beginning of the 30-day public comment period as follows:

Gettysburg Times – 5/11 and 5/13 (the Times ran it twice because their Monday edition is digitalonly and we wanted to ensure that the ad was included in a print version as well) Hanover Evening Sun – 5/12York Daily Record – 5/13

In addition to the paid advertisements in those papers, we sent follow-up contacts about the meeting directly to reporters at the Times, Evening Sun and Daily Record. Of those three, only the Times ran a follow-up article (front page of the 5/23 edition).

Beyond the newspapers, the meeting notice and access information was published on the front page of the County government website. Physical copies were placed in all six public libraries in Adams County. The meeting notice and draft 2025 TIP document were also provided electronically to all 34 municipalities in Adams County with a request to share those documents with municipal elected officials and Planning Commissions. I know that some municipalities included this announcement on their meeting agendas.

Finally, the meeting notice and draft 2025 TIP were also sent to the distribution list we maintain for the <u>Adams County Transportation Planning Organization (ACTPO)</u>, the entity responsible for developing (in coordination with PennDOT) and adopting the TIP. This distribution list is open to any resident who wishes to receive updates on ACTPO's meetings. If you, or anyone else, would like to be added to that distribution list, please let me know and I will add them.

Personally, after 26 years with Adams County I've lost count of the number of Supervisor, Borough Council, Planning Commission and other public meetings I've attended. I enjoy them and I do sincerely wish that there was more public engagement/participation at all public meetings. I also believe that most public officials would welcome more input and participation. However, in reality attendance at these meetings is often been very sparse unless there was something controversial on the agenda.
