ADAMS COUNTY COURT OF COMMON PLEAS
PROCEDURES TO PETITION THE COURT FOR APPOINTMENT
TO FILL VACANCY IN THE OFFICE OF CONSTABLE

1. The procedure for the filling of a vacancy in the office of constable for a borough, ward or township is set forth in 44 Pa.C.S.A. §7121.
2. Persons who are interested in being appointed to fill a vacancy should first determine whether a vacancy exists and the expiration date for current term of office from the Office Voter Registration for Adams County.
3. The applicant for the vacancy must reside within the borough, ward or township where the vacancy exists.
4. Once a vacancy is verified the applicant should complete the Petition and circulate it within the borough, ward or township and obtain the signatures of at least ten (10) persons, registered to vote in municipal elections, on Exhibit "A" attached to the Petition. It is recommended that more than ten (10) signatures be obtained in case any of the signatures are challenged.
5. Once the Petition is completed and the signatures of the registered voters are obtained the applicant must file the Petition in the Office of the Clerk of Courts of Adams County and pay the required filing fee.
6. The Petition will be forwarded by the Clerk of Courts to a Judge assigned to address such petitions and a hearing will be scheduled for a date approximately 60 days later.
7. Once the applicant receives the Order scheduling the hearing he/she must serve a copy of the Order upon the Adams County Commissioners, the District Attorney of Adams County and the borough council or board of supervisors for the municipality where the vacancy exists and provide the Court at the time of the hearing with proof of such service.
8. At the time of the hearing the applicant must appear and produce evidence that he/she qualifies to serve in the position of constable, that the signatures attached to the Petition are, in fact, currently registered voters of the borough, ward or township where the vacancy exists, and that the applicant has or intends to satisfy all statutory requirements to serve as a constable.
