### **Commissioners:**

• For the purpose of Employee Retiree Health Care Benefits, the County of Adams has transitioned from being fully insured to self-insured status. With the change to self-insured status, the County, by and through its health care consultants, has been advised that prudent business practices compel the Adams County Board of Commissioners to exercise their right to rescind the Retiree Health Care Benefit that was approved by a previous Board of Commissioners on November 19, 1997 with an effective date of January 1, 1998. The financial impact to the County by continuing to offer the post-retirement health care benefit is to realize an increase in the County's specific and aggregate reinsurance premiums, and a risk of high claims exposure based upon continued coverage of this group.

With recommendation from Solicitor Molly R. Mudd, Mr. Qually moved, seconded by Mr. Martin, to rescind the Retiree Health Care Benefit and to grandfather the active retirees who are currently participating in this program, effective March 20, 2019

Retirement Plan Services Agreement with Haverford Trust Company ("HTC") for
fiduciary services related to the County's Governmental 457(b) Plan, specifically

for a fee equivalent to 0.50% of all assets under management.
