Department of Emergency Services:

- Recommendation from Director of Emergency Services Warren Bladen, and after review by Solicitor John Hartzell, that the Board of Commissioners approve, pending final Solicitor review, entering into two agreements with Teleosoft, Inc., of York, PA, for software services related to a project streamlining the provision of warrant information to emergency responders. The first is a Software License Agreement, at a one-time cost of \$61,620, to complete the software customization, testing, product delivery and installation, and training. The second agreement is a Software Maintenance Agreement, which calls for an annual cost of \$10,000 for software maintenance, troubleshooting, upgrades, and support for the new system. The Software License Agreement is being funded through the County Records Improvement Fund.
- At the request of Warren Bladen, Director of Emergency Services, and John Hartzell, County Solicitor, that the Board of Commissioners approve Resolution 15 of 2017, entitled "Resolution of the County of Adams, Pennsylvania, committing the County to the joint funding and operational support of a regional radio system to be known as the South Central Inter-County Communications Network," with the resolution serving to commit the County to the development of an Intergovernmental agreement for the development, operation, and support of the system, and committing to a common radio system management protocol and governing document, all to be done jointly with Dauphin and Franklin Counties. This network will provide greater redundancies and back-up for Adams County, thereby improving operational flexibility and capabilities for the County's emergency radio system.
