ADAMS COUNTY

Adams County Warden Katy Hileman and Deputy Warden Larry Snyder were recognized and presented Law Enforcement Awards by The Optimist Club of Gettysburg at Wednesday's Commissioners Meeting. May 17 Primary Election Updates

On Wednesday, the Pennsylvania Supreme Court issued an order adopting the Congressional redistricting plan known as the "Carter plan." As part of the order, the Supreme Court also provided an updated schedule modifying the Primary Election calendar for Congressional races and statewide elections as follows:

- First day to circulate and file nomination petitions February 25, 2022
- Last day to circulate and file nomination petitions March 15, 2022
- First day to circulate and file nomination papers March 16, 2022
- Deadline to file objections to nomination petitions March 22, 2022
- Last day that may be fixed by the Commonwealth Court for hearing on objections that have been filed to nomination petitions - March 25, 2022
- Last day for the Commonwealth Court to render decisions in cases involving objections to nomination petitions March 29, 2022
- Last day for the County Boards of Elections to send remote military-overseas absentee ballots April 2, 2022

At this time, the use of *Mail-In Ballots* is in question due to the Commonwealth Court recently finding that voters must cast their ballot at the polls unless they meet specific requirements. Although the Court did not rule against the merits of Mail Voting, they said that the state constitution must be first amended to allow it. It is believed that the Democratic majority PA Supreme Court will eventually uphold Act 77 allowing Mail In Voters. Stay tuned. Once again, the election process for Counties is uncertain causing fiscal and logistical issues for Pennsylvania Counties charged with administering elections.

Please make note this does not change the day of the Primary Election itself, which remains Tuesday, **May 17** under this order!

Treasurer Assists Municipalities

At Wednesday's public meeting, the Adams County Board of Commissioners approved the Adams County Treasurer collecting taxes for the boroughs of Abbottstown and Arendtsville. In many smaller communities it is becoming increasingly difficult to find residents to seek and accept the position of tax collector. Treasurer Crissy Redding and her staff have stepped up to the plate to fill this void in Adams County. With no one seeking the position in these two municipalities, the Treasurer has worked with the officials of Abbottstown and Arendtsville to become their tax collection agency.

At the February 9th Commissioners Meeting, Adams County Court Reporters were recognized with a Proclamation for *Court Reporting And Captioning Week*. The work of our Court Reporters is vital to the keeping and protecting of the official Court Record. It is certainly a special talent to be able to record thousands of words, for long periods of time, with a variety of dialogue and testimony. How County Priorities Fare in State Budget

On Tuesday, February 8, Gov. Wolf delivered his eighth and final budget address, announcing his \$43.7 billion fiscal proposal for FY 2022-2023 in a joint session of the House and Senate. The proposal represents an increase of approximately \$5.1 billion, or 13%, over the FY 2021-2022 enacted plan of \$38.6 billion. With the current surplus in state revenue, Gov. Wolf's budget did not call for a tax increase to coincide with increased spending. While Gov. Wolf recently announced his proposal for spending some of the state's remaining American Rescue Plan Act funds, the Governor's budget proposal also avoided use of these funds to balance the state's expenses.

Notably, the proposal includes a \$36.6 million investment in mental health community base funds. This is an investment that counties greatly appreciate as it tracks with their top priority for 2022, and a long-time fund-ing goal for increased funding to support the crumbling mental health system.

Overall, for counties, the Governor's proposal gives some hope that counties could receive long-needed increases to some critical human services line items; but provides level funding across many other line items. However, working with counties to assure the funds can be used for their greatest 211111212 needs will be essential to a successful FY 2022-2023 budget. There are a number of initiatives proposed to alleviate current workforce shortages and bolster Pennsylvania's economy. Although the initiatives are not directly aimed at addressing the County human services work-force crisis, another county government priority for 2022, they offer increased support for overall workforce development programs and solutions. Finally, the child welfare budget for FY 2022-2023 includes an increase of \$181 million from the enacted FY 2021-2022 budget and counties are eager to work with the administration and General Assembly to assure those funds can be used in the areas of greatest need with respect to another county priority, appropriate funding and reform for the current children & youth system.
